

BY-LAW NO. 98-2

**A BY-LAW TO CONTROL AND REGULATE THE COLLECTION
AND/OR DISPOSAL OF GARBAGE AND WASTE
WITHIN THE TOWN OF ST. ANDREWS**

WHEREAS the Town Council of the Town of St. Andrews deems it expedient for good health and better appearance in the said Town, to provide for the disposal of garbage, and other refuse or waste material, and to control and regulate the collection and/or disposal thereof within the limits of the Town of St. Andrews.

Therefore, BE IT ENACTED by the Town Council of the Town of St. Andrews, a By-law as follows:

1. DEFINITIONS:

In this by-law:

- a.) GARBAGE means refuse and other discarded matter produced within a dwelling house on a regular basis. It shall also mean leaves, grass cuttings, provided that they are in proper containers not to exceed 50 pounds per container; Christmas trees, brush and tree branches, provided that they are tied in bundles not exceeding 3 feet in length, 2 feet in diameter and weighing less than 50 pounds for each bundle; paper and cardboard materials, books, newspapers and magazines, securely tied in packages or bundles, provided that they are not exceeding 3 feet x 2 feet x 2 feet in dimension and not exceeding 50 pounds in weight for each bundle. Household furniture, appliances and miscellaneous items weighing less than 50 pounds each and not larger in any dimension than 3 feet - no containers necessary.
- b.) WASTE means discarded building materials such as lumber and construction materials used for erection, alteration, demolition or repair of buildings or structures, residue from trees such as roots, stumps, trunks and branches larger than 3 inches in diameter, discarded metals, piping, fencing, tools, swimming pools, automobiles, snowmobiles, motorcycles, bicycles or related parts, stones, rocks, sand, gravel, manure, the remains or carcasses of any dead animals, or any other discarded material other than garbage, petroleum products, radio-active or any other hazardous wastes.

1. DEFINITIONS: - continued
 - c.) COLLECTOR means a person or company under contract with the TOWN for collection of garbage.
 - d.) CONTAINER means a water tight galvanized metal or plastic garbage container with a maximum capacity of 3.2 cu. ft and not less than 2 cu. ft with a fitted lid and suitable handles weighing not more than 50 pounds when full. It shall also mean an opaque polyethylene plastic garbage bag of 1.5 mil. thickness, with a maximum capacity of 8 cu. ft and not less than than 2 cu. ft, securely tied at the top, not to exceed 50 pounds per bag; cardboard boxes securely tied or fastened with a maximum capacity of 8 cu. ft weighing not more than 50 pounds when full. Containers shall not mean plastic shopping or grocery bags, paper or cloth bags.
 - e.) DWELLING HOUSE means a place of residence including apartment buildings, rooms, cottages and summer homes.
 - f.) TOWN means the Town of St. Andrews and area within the limits of the municipality.
 - g.) TOWN OFFICIAL means the Superintendent of Public Works, duly authorized by the Town to enforce this by-law.
2. GARBAGE shall be collected by the TOWN or a COLLECTOR from all DWELLING HOUSES situated within the Town limits, once each week.
3. Not more than 10 CONTAINERS of GARBAGE will be collected at any one DWELLING HOUSE on any collection day.
4. Special Collection may be scheduled by the TOWN and details of such special collections shall be published from time to time, by the Town or a COLLECTOR.
5. CONTAINERS shall be placed by the occupant in front of his DWELLING HOUSE just off the traveled portion of the street so as not to interfere with traffic, or at such other convenient location as may be approved by the TOWN OFFICIAL.
6. CONTAINERS shall be placed by the occupant of the DWELLING HOUSE for collection not later than 7:00 o'clock in the forenoon of the day of collection and not earlier than 8:00 o'clock in the evening of the previous day.

7. Empty CONTAINERS and any materials not collected shall be removed by the occupant of the DWELLING HOUSE by 8:00 o'clock in the evening of the day of collection. The occupant of the DWELLING HOUSE shall maintain CONTAINERS in good condition at all times, such condition must meet the approval of the TOWN OFFICIAL.
8. GARBAGE which is stored by the occupant of a DWELLING HOUSE prior to the collection date shall be kept in proper CONTAINERS so as to prevent an unsightly appearance, pest infestation, or being accessible to dogs or other animals.
9. No occupant of a DWELLING HOUSE shall suffer or permit a CONTAINER containing GARBAGE to remain upon property under his control for a period exceeding ten days without placing the contents for collection as per the provisions of this By-law.
10. All GARBAGE and WASTE generated within the TOWN shall be disposed of at an approved Solid Waste disposal site.
11. The collection and disposal of GARBAGE from business, commercial, industrial, institutional, or government establishments shall be the responsibility of the owners or occupants thereof and not of the TOWN.
12. No business, commercial, industrial, institutional or government establishments shall suffer or permit any GARBAGE to remain upon premises under their control for a period exceeding seven days without disposal as per the provisions of this By-law.
13. The collection and disposal of WASTE from DWELLING HOUSES, business, commercial, industrial, institutional, or government establishments shall be the responsibility of the owners or occupants thereof and not of the TOWN.
14. No persons, business, commercial, industrial, institutional, or government establishments shall suffer or permit any WASTE to remain upon property under their control for a period exceeding ten days without disposal as per the provisions of this By-law.

15. Equipment or vehicles used to transport material to the approved Solid Waste disposal site shall be covered or shall have a canvas or tarpaulin of adequate size to cover all materials hauled.
16. No person shall throw, dump, place or deposit, or cause to be thrown, dumped, placed or deposited any GARBAGE or WASTE on any street, road, sidewalk, square, lane, alley, culvert, ditch, drain, sewer, wharf, beach or shore, or anywhere within the limits of the TOWN, or in or on the bank, beach, shore or waters of the Saint Croix River or Passamaquoddy Bay or any Harbour, adjacent to the limits of the TOWN; except in compliance with the provisions of this by-law.
17. The TOWN OFFICIAL shall have the right to enter at all reasonable times, upon any property within the TOWN for the purpose of making an inspection or enforcement of this by-law.
18. The TOWN OFFICIAL shall give written notice to all persons or companies who violate any section of this By-law, to correct such violation within a specified period of time. Upon failure of such persons or companies to comply with such written notice, the TOWN OFFICIAL may cause GARBAGE and WASTE to be removed and disposed of at the expense of such persons or companies. An information for breach of this By-law may be laid in the name of the TOWN OFFICIAL before a judge of the Provincial Court.
19. Any person or company who violates any provision of this By-law is guilty of an offense and liable, on summary conviction, to a fine not exceeding two hundred dollars (\$200).
20. By-law No. 23 enacted May 2, 1967, and all amendments thereto, is repealed upon enactment of this BY-LAW.

TOWN OF ST. ANDREWS BY-LAW NO. 01-2
A BY-LAW TO AMEND BY-LAW NO. 89-1, BEING A BY-LAW TO
SEASONALLY STOP UP AND CLOSE A PORTION OF JOE'S POINT ROAD
TO VEHICULAR TRAFFIC

BE IT ENACTED by the Council of the Town of Saint Andrews as follows:


1. All that portion of the Joe's Point Road, so called, in the Town of St. Andrews extending from the existing driveway access to the property on the other side of the beach access road to the Ferry Landing, so called, on the shore of the St. Croix River shall be stopped up and closed to vehicular traffic but not to pedestrian traffic for a seasonal period from April 15 to October 31 inclusive of each year and Algonquin Properties Limited, its successors and assigns, is hereby authorized to erect barriers to enforce the observance thereof.


