DISCLOSURE OF CONFLICT OF INTEREST

PRESENTATIONS

Caroline Davies, President, Passamaquoddy Lodge Board, and Lezlie Leblanc, Administrator, Passamaquoddy Lodge, presentation on proposed new Passamaquoddy Lodge Nursing Home.

The presentation provided an overview of background work that has been completed investigating the location, design, and models for a new facility. Have a strategic plan to look at a home style model with 60 individual rooms with bathroom facilities. The facility would be designed with COVIC-19 and pandemic responses designed to ensure safety of the residents. Next steps are to determine best site, brief politicians, obtain government approval, and obtain land. Estimated cost of work to be completed is \$25 million. The request to the Town of Saint Andrews is for a Memorandum of Understanding for first right of refusal on land (Bar Road at Champlain Ave), rezoning land to institutional, formal support for this proposal, assistance in obtaining federal, provincial, and other funding, and potential financial contributions from the Town.

Council received the presentation and acknowledged their participation to support the process and look forward to more discussions on land, funding, and support.

Bethany Young and Freya Clark, Nature Trust of New Brunswick 2020 Year in Review

The presentation provided Council with a review of the 2020 season and nature protecting projects that have occurred. Projects the Nature Trust completed around Saint Andrews and the surrounding area included Pagan Point with 100 trees planted to stabilize the shoreline, Caughey Taylor Preserve with trail work to clear Taggart's Brook Loop, and Navy Island trail work and discovery of a Loyalist cemetery. The Nature Trust goal is to protect 15,000 acres of land by 2023, nearly doubling currently protected lands.

Council received the presentation and thanked the Nature Trust for brining projects to Council's attention that they were not aware of. Council was open to strengthening the partnership with the Nature Trust with future projects.

Approval of the 2021 Budget

Motion: 393 - 11/20

That Council approves the 2021 General Operating and General Capital for the Town of Saint Andrews, as well as the projections for the same for 2022-2025 be approved;

And that, the 2021 General Operating Fund Budget totals \$5,157,864 including a Tax Warrant of \$4,183,356 based on a mill rate of \$1.2600 for each \$100 of assessment. Council orders and directs the levying by the Minister of Local Government and Local Governance Reform of said amount on Real Property liable to taxation under the Assessment Act within the Town of Saint Andrews.

That the General Capital projects in the 2021 Budget be funded by \$799,093 from the General Operating Fund, \$140,000 from long-term borrowings, \$2,862,662 from Government Grants, and \$250,765 from the General Capital Reserve Fund.
