D. PRESENTATIONS

Andrew Holloway, Red Cross - link socially vulnerable adults to resources in New Brunswick, determinants of health. Want to keep adults healthy and active. Target 65 and older for participants. The goal is system navigation through the province. We are highlighting this as a pilot project and hoping this will be implemented across the province. Created an asset map of Saint John and Saint Andrews to leverage programs, processes, and services to get them into the hands of the public. Saint Andrews was selected for the demographics, community, and economy. This is a volunteer adult program to help seniors. Red Cross will help

coordinate but volunteers are the key backbone to this. CareDove website is being created to leverage technology to help support older adults.

Deputy Mayor Henderson - I want to say thanks for this and that we are selected by Red Cross to participate. Thank you for considering Saint Andrews and Saint John. My question is how can Council help?

Andrew - Optics. If word gets out if this is silly, it will stop it. But leveraging space to run these meetings, keeping positivity to the project, we will provide posters and ideas to go with Council. All input from staff and Council. I want to build relationships in the community. If you can help with referrals for participants and volunteers. That type of promotion and support.

Councillor Groulx - You mentioned at the outset, you are looking for Red Cross volunteers?

Andrew - Red Cross volunteers need 2 hours of prep training and new volunteers will need 5 hours. This is more about how to react to vulnerable health issues and spotting issues. Supporting people when necessary and have training.

Councillor Groulx - What are you asking volunteers to do?

Andrew - We have a fluid model set up. For example, can do Heart and Stroke programs with groups. If it is teaching how to use Zoom, we will work with practices to get people trained. It comes from what the participant needs. You will be paired with someone for 4 - 6 weeks.

Councillor Groulx - What is the volunteer doing?

Andrew - Helping with the first step getting people into the support they need. There are a lot of resources in the province and the vast majority of programs are not touched. This is an alternative way to get the older adults the assistance they need that is provided in the Province. Those with similar ages will support those of similar ages.

Councillor Akagi - This is a great program and hopes it takes off in Saint Andrews.

Andrew - We will be gifting the Town 8 - 12 wifi enabled Ipads in Town to help link up and sign up for programs.

Mayor Naish - What is the timeline?

Andrew - Idea starts in the spring of 2021 and gets trained through the process. August of this year to do a media campaign to spread the word for participant signups. Ipads will come at this time. We are hoping by September with volunteers and participants with the first phase complete by December. We have an additional 1.5 years to go through the process. In March 2023 we will have a report to provide to Council and the Province on the project.

I. NEW BUSINESS

1. FA210104 Amendment No. 1 to By-Law No. 75 Regulating and Licensing Peddlers and Transient Traders

Councilor Harrison - Conflict of Interest 8:25 p.m. Returned at 8:40 p.m.

CAO Spear - This goes back to the Committee Meeting and discussions on an amendment to the Peddler's Permit for 182 Water Street. There was concern among Council that this amendment would open up the permit to the whole public. Under the old permit, it gave the Clerk a right to issue a permit under the By-Law. We have understood the will of the Council and have not issued permits for food trucks. A few years ago we tried to update the By-Law but have not completed this. We have had a moratorium on permits. 182 Water Street, the proposed amendment exempts this particular project. As long as Council has approved it and they have got their temporary Zoning from PRAC, they would be exempt from the permit. It is just saying someone who wants to do this in the future that the process

is to Council and then to PRAC. There is no concern from staff or the solicitor, this will still limit those to come for permits. The council should consider going to the First Reading sometime this month with more discussion.

Councillor Groulx - I am still confused by this amendment, it still does not make sense to me. So, it is something we have not approved, PRAC, and PAC has not approved. I have read through the old By-Law, under this our Clerk can approve a temporary business. If I am reading the will of the Council, there is no problem with the Clerk moving forward with direction from Council for 182 Water Street.

CAO Spear - My concern is under the By-Law; temporary business is 6 weeks. We want to move this away and bring a case by case basis. We want to make sure that Council still has a say in these types of development. If you want the treatment go through the process to Council and PRAC. Temporary business is part of the definition of the By-Law, with the rewording, 182 Water would be exempt from this By-Law. This develops a secondary mechanism to go through Council and PRAC.

Deputy Mayor Henderson - I am concerned about the specific exception. I am concerned that PRAC can approve things subject to us changing the By-Law. This 182 Water Street was approved by PRAC, but they did not have to come to the Town. I do not think the best practice of PRAC approval and modify our By-Laws.

CAO Spear - It is good practice, with this style of development, to come back to the Municipality to ensure support for it. Through the Community Planning Act PRAC can make judgments. The process was never thought of in this process. But changes like large signs, etc. have been made to PRAC and minor variances are made. Large variances like 182 Water, PRAC wants their input. Kind of the reverse situation on asking PRAC for their opinion. In our efforts, we are trying to say Council has to be asked and give the PRAC the ok to approve that type of business. It is important to note that there is future development at this site and if something happens and development does not occur, the project will not be allowed to continue. PRAC cannot issue another temporary one year ask.

Mayor Naish - We should lobby that PRAC cannot make changes to us without consultation. Our Planners brought this forward for discussion.

Councillor Groulx - This situation is unique, in that there are two By-Laws at play, Zoning, and Peddlers Permit. A variance has been received by PRAC. PRAC has followed their process, the issue that comes up is the Peddler's Permit. We can let the Clerk issue a temporary permit for 6 weeks. The Clerk can issue multiple permits over this time and we would not have to make an amendment. We can charge the \$50.00 for each permit and move on. Hit the easy button.

Deputy Mayor Henderson - Continuing to approve a 6-week process, I think that the reason is to remain temporary. Doing multiple permits in a row goes beyond the thought of the process. This is a significant change and goes through three readings. It should have a hearing of objections. My concern is contrary to our by-laws have some concerns with PRAC. I am worried about a lot for sale at HMS, I am going to have a hard time saying no to offering food trucks based on precedence.

CAO Spear - To the Deputy Mayor, we are not setting precedence as this is a case by case basis. The business plan is aggressive with construction meeting town standards. This is a good thing if it affects other By-Laws. I will remind Council we spoke to the BIA and Chamber and they provided support. I would say this is not a regular set up in a parking lot and go. We have to be cognizant of this. It is temporary for 1 year and no other approval after that. I am hearing Council has concerns over this. We should follow

through and we can look at alternative wording. This By-Law is what protects us from the permits.

Councillor Groulx - The other question I have is, how changing this definition would in any way address the current limitation on the 6-week clause. It would still be there, even if you issue a permit.

CAO Spear - Means a business that has not been approved by Council and PRAC, says we need two approvals with an exemption to this By-Law. It is no longer a temporary business, and a permit under the By-Law is not required if there has been approval by the two bodies. The clerk and I will work on the wording of this to reduce the confusion. We will bring a recommendation forward on the clear intent of the motion.
