- 2) Deliver the application form with **all required documents*** and deposit to St. AndrewsMarket Wharf, Saint Andrews Municipal Office, 212 Water St., Saint Andrews, N.B.
- 3) Applications are to be submitted prior to commencement of operation of said business for the current year.
- 4) Fees to be paid for the full year and shall not be prorated for a partial season.
- 5) The two hundred and fifty dollar (\$250.00) deposit shall be refunded if the application is withdrawn or rejected prior to commencement of said operation for the current season.

* The following **must be included** with your application each year:

1. Colour Photograph of the vessel (5" x 7" minimum size).
2. Copy of current VESSEL CERTIFICATE OF INSPECTION.
3. Proof of BUSINESS INSURANCE
4. Deposit of two hundred and fifty dollars (\$250.00).

CONDITIONS OF LICENSE for Fisheries and Aquaculture Vessels:

Operator hereby agrees to :

1. Honour the "No Wake" zone within 300ft of the wharf and breakwater.
2. Immediately inform the Wharfinger, in writing, of any changes to details submitted via this application during the course of the operating season for which a permit has been issued.
3. *Comply fully with **Bylaw No. 20-03** A BY-LAW OF THE TOWN OF SAINT ANDREWS RESPECTING MARKET WHARF (www.townofstandrews.ca).*
