CAO Spear provided background on the Electronic Medical Records process.

Councillor Groulx - Mr. Spear, you mentioned that we have lost the Nurse Practitioner, can you elaborate.

CAO Spear - The physical nurse position is being filled as we speak. The current practitioner moved closer to her home town.

Councillor Groulx - I thought we would have the Nurse start now.

CAO Spear - Still moving ahead with a Nurse Practitioner but delayed with the new doctor and getting her practice going.

Mayor Naish - One of the issues of selecting our medical record system, this provides the ability to bill Medicare and the Horizon system is only a transfer system. This is the best option for our doctors and nurses. When the nurse comes in, we will get the Horizon system too.
