## 1. 5 Year Municipal Designated Highway Improvement Discussion, PW210604

CAO Spear provided an oversight of the 5 Year Municipal Designated Highway Improvement plan for submission by the end of June 30, 2021. Some improvements have come from the project including ditching and paving. Funding has been limited from the Province since 2018. Staff need direction on moving forward with the document. ## 1. 2021 St. Andrews Farmers Market Request Use of Water Street Discussion, BTHC210601

Council discussed the potential of use of Water Street as an extension to the Farmer's Market. Staff provided an overview report that highlighted with a one-way street, there are issues with traversing the streets and big trucks getting stuck near the Wharf without turning radius. Council discussed the options of closing the street and the feasibility of flow of traffic in the downtown. Council discussed the ability to set specific times for deliver tricks and alternative routes for deliveries. Due to being on a select route, it is difficult to alter this as Council has limited powers to do so. Council directed staff to reach out to the Farmer's Market representatives on trying to create a hybrid system for the Market to use road space.

### 2. Chiller replacement at Arena, RCS210604

Council was presented with a Staff report outlining the current status of the chiller system and compressor unit. In the discussion, it was noted this equipment is out of date and have the potential to create issues this winter if not repaired. Staff requested that the chiller be replaced, and one compressor undergo repairs. Staff highlighted several the safety issues and concerns, specifically regarding the ammonia chiller system and the hazards it can have to human health. Council discussed the report and directed staff to bring a motion forward at the next meeting to approve the repairs up to \$100,000. Funding would be from the COVID-19 funding provided by the Province and the Sir James Dunn Foundation.
