D. PRESENTATIONS

1. Neil Shorthouse, Chair of the Tourism Accommodation Levy 2022 Budget Presentation

Neil Shorthouse provided an overview of the Tourism Accommodation Levy, #ExploreStAndrews budget process for 2021, and the proposed budget for 2022. The goal is to create Saint Andrews as a preferred destination for tourism in Atlantic Canada. A 2021 overview of budget spending was provided including supporting local events, Chamber of Commerce administration, destination marketing and management, and community recognition. The total budget for 2021 was \$169,272.00 with a combination of the TALB and Town of Saint Andrews portions of Levy funding. The Welcome Centre was a key service provided to the community to help with additional bookings for accommodations and tourism attractions. Objectives achieved include the development of a unique website, New Brunswick marketing partnership, supporting local events, summer and fall season of advertising, the Explore Saint Andrews Pass, an active new Welcome Centre, and the creation of the Anchor Awards.

Navigating the 2022 season will include organizational capacity and scope of activity, pandemic affected consumer sentiment towards travel, much shorter and customers spending less, the labour shortage in the community has affected the hospitality sector and the experiences for customers. Housing is also a key issue that is affecting our labour shortage. 2022 Budget priorities include targeted advertising, maximizing visibility at tourism trade and consumer events, building out our website and showcasing our unique experiential products, supporting local events, supporting operators in navigating business limitations, supporting the Welcome Centre, developing community profile as an attractive group destination, and recognize outstanding frontline services. Based on our projected budget we are anticipating \$194,000.00 to be approved.

Council thanked Mr. Shorthouse for the presentation on the Tourism Accommodation Levy Board (TALB) and ExploreStAndrews. Council asked how TALB would expand the season, address labour shortages, and if the Town has been involved in any process. Mr. Shorthouse noted that the labour shortage has been a larger discussion with the Tourism Association of New Brunswick but will have to be looked at as a collaborative approach at the local level. The Town has been part of the TALB discussions and looking at options to support the labour shortage and housing situations. Council applauded TALB and its long-term strategy using a two-tiered budget based on projects and developments as they come forward. Council noted that there has not been a single complaint about the tax levy and the community is supportive of the initiative. Council asked how the social media presence and website development will be enhanced. Mr. Shorthouse identified that they plan to hire a staff member to work on these and getting local stories from businesses, enhancing accommodation, and tourism operators to help build the story and brand of the community. Council brought forward the discussion on the White Papers on Municipal Reform and the potential impacts to local and regional tourism initiatives. Council hopes that the funds collected in Saint Andrews will remain here and that the TALB can sit on a regional board looking at collaborative initiatives to support tourism. Mr. Shorthouse noted that this has been a discussion with the Provincial Tourism Council and that there is still planning and processes to review but hopes for the same outcome that Council has supported.

2. Briana Cowie, Executive Director, Eastern Charlotte Waterway Presentation on the Greenhouse Gas Mitigation Plan and Energy Study for the Town of Saint Andrews

Briana Cowie and Aldea Poirier from the Eastern Charlotte Waterways provided a presentation on the Greenhouse Gas Mitigation Plan and Energy Study for the Town of Saint Andrews. The objectives of this project were to create a baseline inventory of greenhouse gas emissions, a strategy to reduce the emissions, and goals to achieve. We used data from 2020 to review municipal buildings, vehicle fleet, streetlights, water and wastewater. and solid waste. We used the PCP protocols to create the inventory and used energy consumption data that was converted to greenhouse quantification. Additional information included New Brunswick Power information, heating oils, fuel, and propane consumption for fleet and Zamboni. Results that buildings are the largest emitter and consumer of greenhouse gas emissions followed by water and wastewater, vehicle fleet, streetlights, and solid waste. Buildings are 49% of all corporate sector emissions, vehicle fleet is 10% of emissions, and water and wastewater were 30% of emissions. A 2008 energy audit was used as part of a baseline to see differences between then and now. We have seen a 22% reduction between 2008 and 2020. The next step is to set an emissions reduction target and develop a local action plan. Our suggested reduction plan is 30% below 2020 levels by 2023, a reduction of 202 tonnes of CO2e.

Council thanked Eastern Charlotte Waterways for their hard work and efforts in putting the study together for the Town. Council inquired if similar

trends for emissions are being seen with other municipalities on greenhouse gas emission. Ms. Cowie noted that they are seeing similar trends with other municipalities and was impressed to see the 2008 strategy was used to reduce levels of emissions and the Town's continued commitment to this process. Council noted that in order to meet a 30% target for reduction, we will have to look at larger projects as we have completed many of the smaller projects to reduce emissions. Council noted that it would be great to see continued reductions and investments into our assets. Saint Andrews is known as a community that takes pride in science research and to be a leader in reduction, innovation, and investments that can pay for themselves over time.

WHEREAS RCMP cost increases will disproportionately impact rural communities; and

WHEREAS Municipalities are eager to work more closely with other orders of government and the RCMP on contract policing issues to ensure the financial sustainability of contract policing and to maintain the service levels necessary for community safety; therefore

BE IT RESOLVED That the Town of Saint Andrews joins the Federation of Canadian Municipalities is calling on the federal government to absorb all retroactive costs associated with the implementation of the new RCMP labour relations regime; and

BE IT FURTHER RESOLVED That the Federal Government should commit to ensuring municipalities are property consulted prior to implementation of measures that impact local fiscal sustainability and ability to maintain effective levels of police services in communities.
