**AMENDMENT MP20-02-02 TO SECONDARY MUNICIPAL PLAN**  
**MP20-02 FOR PID 15210289 LOT ON CARLETON STREET**

The Council of the Town of Saint Andrews, in compliance with *Section 111 of the Community Planning Act* of the Province of New Brunswick, intends to hold a Public Hearing of Objections and/or Comments under the proposed **Amendment MP20-02-02 to the Secondary Municipal Plan MP 20-02 for PID 15210289, Lot on Carleton Street for Mary Truemner on Monday, November 14, 2022, at 6:30 p.m.** The Amendment would allow for PID 15210289 to be exempt from any policy or proposal in the Secondary Municipal Plan MP20-02. The applicant wishes to construct a 1,200 sq.ft., two-storey, cape cod-style single-unit dwelling. The meeting will be streamed using the teleconference system Zoom, and live-streamed via the Town of Saint Andrews Facebook page.
