I. INTRODUCTION, CONSIDERATION AND PASSING OF BY-LAWS AND MOTIONS

1. Planning & Community Development Committee - Councillor Harland and Heenan

1. Amendment Z22-11 to the Zoning By-Law Z22-01 for First and Second Reading, PCD250102

Clerk Nopper clarified with Planner Gopen that the changes to traditional building materials or facsimiles for fencing are only for the front and flankage yards within the Historic Business District; only fences that are visible from public streets. PAC's recommendation was to extend that to the entire Town Plat and Environs. If Council wants to make the recommended change, it would require another Public Hearing of Objections be held for this change to the Amendment.

CAO Spear noted transparency of chain-link fences allowing people to see residential gardens would be lost as other types of materials might not provide that view. Consideration for transparency that we have talked about as being important might disappear.

Councillor Heenan stated have a couple problems first in terms of transparency. People with fences want to see their gardens. I have seen wooden fences fall into disarray. I do not see that as a plus for the Town. I have lived beside a wooden fence and a chain link fence, and chain link is far nicer than a falling fence. If not put up correctly, they all look shabby. I would not support the By-Law to change it

Council had concerns on how this would affect the existing fencing in the community including rear yard fencing and fencing at the schools and about passing a blanket by-law. Concerns about deer fencing and how it may be affected by these changes was also discussed. Also, wanted clarification on the height restrictions on front yard fences.

Planner Gopen clarified that the type deer fencing involving just wrapping fabric around hedges is not considered under this amendment; this is stakes in the ground and some kind of barriers between stakes types of fencing. He also noted that Council could exempt non-residential uses. Only talking front and flankage yard fences. Not rear yards. Areas around the school would be considered side yards. If you wish to go with options, can exempt institutional uses and make residential only. Basic maintenance of existing fences is ok if you are not dealing with posts in the ground. Existing fences would be grandfathered in. If you are replacing a whole fence or when there is soil disturbance involved, then it is basically considered a new fence. At that time if you require variances or new permit we look at that as a new fence needing to meet up to date by-laws. This amendment, either way, does make variances easier and gives development officers a bit more discretion whereas before everything was going to PAC. In certain cases, i.e. high school needs to put a fence in a front yard to protect a garden, could bring that to PAC for a decision. There are ways to deal with it. My advice would be if you do the PAC amendment have that apply to only residential

uses in the Town Plat and Environs so that would exempt schools, churches, Arena Complex etc. In terms of maximum height currently the by-law says anything between 3.3 and 6.6. feet; anything over 3.3 feet in front or flankage yard has to go to PAC for terms and conditions. Generally they have been requiring transparency and these discussions around traditional building materials have come up. Transparency is common as a term; it could be chain link, wooden slats, rot iron, etc. The PAC amendment would just say in the Town Plat as well as the Historic Business District you would have to have the transparency and you would have to do it with traditional materials which means you cannot use chain link.

3. Public Works & Public Safety Committee- Councillors Bennett and Neil

1. 18 Marshall Road, Bayside Demolition Order and Removal Order as per By-Law No. 23-02 Dangerous or Unsightly Premises, PWPS250311

Council wanted clarification on what is meant by immediate. This is a costly proposition. Assume will have a right to put a lien on the property.

Clerk Nopper - Request for Proposal process will take a couple of months. Process is the Town would apply to Minister of Finance to apply any expenses that are done by the Town to the property tax and the Minister of Finance would provide the cost of the work completed by the Town back to us. We will recoup our costs, but it will take time. There would be a process to which we do attain the funds back and then any costing is under the Acts are put on to the property tax for that particular individual.

Council noted should be given a heads up on any demolitions. We should have ample warning that a demolition request is coming forward so we can do a little research and can be prepared for people who may come to a meeting where a demolition is being discussed. If it is a safety concern, I guess that trumps everything.

CAO Spear - We did bring this up a couple of weeks ago on the registers just to give you a heads up. We have been working with the landowner for months to help them meet compliance with the by-law, but they stopped accepting documentation from us. This is kind of the next step. We will still work with them. Now we can say that Council is very serious about this so will you comply now.

Council questioned is it necessary to move the vehicles as it will be a considerable expense to the landowner. Also were concerned whether due diligence has been followed in these circumstances.

Clerk Nopper - Under Policy for Derelict Vehicles has been thoroughly reviewed by By-Law Enforcement as well as opinions received by the Building Inspector regarding the vehicles that were on site. Many are overgrown, not moveable, have flat tires, do not have the ability to move, start or function. There are boats with holes in them, a camper with a collapsed roof, etc. Everything was looked at with a fine tooth comb. Made sure it met the by-law and policy qualifications

Council stated understand when we passed this by-law it would only be enforced if there was a complaint

CAO Spear - This was brought about because of complaints from multiple neighbours. Staff are not going out looking for violations. We wait until we hear from the community and then act on those complaints. This particular case has been going on for months and months to try and help deal with this. Prior to Local Governance Reform this was the way it was dealt with in Town; a complaint driven process.

I would like to thank the drummer Greg Mansfield for coming, Clerk Nopper and staff for their support, and to Council who have been very supportive of the Indigenous activities that we have tried to do.


